

NON-DISCLOSURE AGREEMENT

1. Confidential Information may also include information disclosed to a party by third parties at the direction of a Disclosing Party. Confidential Information shall not, however, include any information which the Receiving party can establish (i) was publicly known and made generally available in the public domain prior to the time of disclosure; (ii) becomes publicly known and made generally available after disclosure through no action or inaction of Receiving Party; or (iii) is in the possession of Receiving Party, without confidentiality restrictions, at the time of disclosure by the Disclosing Party as shown by Receiving Party's files and records immediately prior to the time of disclosure. The party disclosing the Confidential Information shall be referred to as "Disclosing Party" in the Agreement and the party receiving the Confidential Information shall be referred to as "Receiving Party" in the Agreement.

2. Non-use and Non-disclosure: The Receiving Party agrees not to use any Confidential Information for any purpose except to evaluate and engage in discussions concerning a potential business relationship between the parties hereto. Receiving Party agrees not to disclose any Confidential Information to third parties or to its employees, except to those employees who are required to have the information in order to evaluate or engage in discussions concerning the contemplated business relationship. The Receiving Party shall not reverse engineer, disassemble or decompile any prototypes, software or other tangible objects which embody the Disclosing Party's Confidential Information and which are provided to the Receiving Party hereunder.

3. Maintenance of Confidentiality Information: The Receiving Party agrees that it shall take all reasonable measures to protect the secrecy of and avoid disclosure and unauthorized use of the Confidential Information. Without limiting the foregoing, Receiving Party shall take at least those measures that Receiving Party takes to protect its own most highly confidential information and shall have its employees, if any, who have access to Confidential Information sign a non-use and non-disclosure agreement in content substantially similar to the provisions hereof, prior to any disclosure of Confidential Information to such employees. WHEREAS 'NRDC' and **'RSCPR'** recognize the respective strengths of the two organizations and accordingly agree to cooperate in the development of technologies and their successful transfer to industry for commercial exploitation and socio-economic benefits.

'RSCPR' also agrees to provide 'NRDC'/Licensee of 'NRDC' as the case may be, technical and engineering know-how relating to such Technology (ies) / Know-how, etc. consisting of documented technical information on the mode of working and using the same by an industry, as may be necessary to commercialize the said Technology (ies) / Know-how, etc. and associated patents / designs / copyrights / trademarks, etc. by 'NRDC' during the currency of this MOA being in force.
3. 5. But the legal expenses to be incurred in this regard as well as the damages to be received out of it will be shared between NRDC and 'RSCPR' in the same ratio as revenue sharing i.e. 50:50.

The expenses in this regards shall be shared in the same ratio as revenue sharing, i.e. 50:50 and similarly the compensation awarded by the court will also be shared in the same ratio of 50:50 by NRDC and 'RSCPR'.

licensee(s) and legal representatives at all times against all possible claims or demands, damages or any action or proceedings commenced by the 'RSCPR' or any person or persons through 'RSCPR' or against the 'RSCPR' or the NRDC before any court, Tribunal or fora. All costs / legal expenses that may arise from such proceedings shall be borne by the 'RSCPR'.

Thereafter such Technologies assigned to 'NRDC' shall be reassigned to 'RSCPR'. 'NRDC' also agrees not to grant any further licence(s) of the commercialised Technologies to any further party (ies). All amount accrued for payment to 'RSCPR' by 'NRDC' on the date of termination shall be paid by NRDC after closing of annual account of 'NRDC'. As for payment accruing thereafter from such commercialised Technologies in respect of which licence(s) have already been granted by 'NRDC' and subsisting on the date of termination of this MOA, 'NRDC' will continue to remit them to 'RSCPR' as if the MOA is in full force and effect; and
- ii. 411014, Maharashtra, hereinafter referred to as "Rubicon" (which term shall so far as the context
admits be deemed to mean and include its successors, administrators, executors and assignees) of the
Second Part.

1. Introduction

THE COLLEGE has decided to partner with RUBICON for the conduct of Tomorrow's Foundation
Connect with Work Program (hereinafter referred to as "Training Program") at THE COLLEGE.

2. THE COLLEGE Responsibilities:

- 2.1 Shall nominate one person with adequate accountability and responsibility to coordinate the
