E-GOVERNANCE POLICY DOCUMENT

Introduction:

Electronic governance or e-governance is the use of information and communication technology (ICT) for delivering organizational services, information, communication, integration with organizational non-organizational entities and exchange of services between organizations to stake holders for implementation of good governance.

Objectives:

The E-governance is implemented in several functioning of the institution for

- 1. Implement and achieve effective and efficient functioning.
- 2. Enhance and promote transparency and accountability in various institutional functioning's.
- 3. Implement maximum efforts to reduce paperwork.
- 4. Expediting online communication between internal and external entities of the institution.
- 5. Easy access to information.
- 6. Propagate institutional Goal, Vision, and Mission through enhancing global visibility.

Institute E-Governance policies:

With objective of efficient and simplified implementation of governance within institute it was decided in CDC and GB to propagate e-governance in maximum activities of institute functioning.

1. **Institute Website:** The JSPM's groups of institute have its own software cell as "Digital Content Development DCD-ARQAC, JSPM-TSSM, Pune" which plays important role in implementation of E-Governance. The website act as mirror of institute provides information related to organization, Quality policy, Vision and Mission, Institute staff and their profile, Approvals and Affiliation to various regulatory bodies, Admission and admission process, Course offered, Academic calendar and Time table, Student Support and activities, Training and Placement, Co-curricular and Extra-curricular activities, Infrastructure and facilities available etc. To update the institute website the institute

website incharge is appointed and responsible to collect the relevant information from respective activity incharge and convey it to the corporate "Digital Content Development DCD-ARQAC, JSPM-TSSM, Pune".

2. Student Admission: The Admission committee is created in the institute and is responsible to provide information about current admission procedure as per the DTE, Government of Maharashtra on institutional website. The entire B. Pharm and M. Pharm admission procedure is online and transparently carried out by Admission committee under the guidelines of Director of Technical Education, Government of Maharashtra. The numbers of vacant seats after the government rounds are informed through the institute website for admission seekers. The website also has a provision to apply online for institute level. The Pricipal, Admission committee and ARC coordinators are responsible for smooth conduct of admission process.

3. Examination:

SPPU online Form- The institute is affiliated to Savitribai Phule Pune University since its establishment and follows the online examination related rules and regulations advocated by SPPU. The related activities like Filling of examination forms, revaluation forms, photocopy forms, obtaining hall tickets, receiving of examination papers, uploading of internal marks, etc. are through the online mode only.

4. **Online examination-** JSPM's organizations "Digital Content Development DCD-ARQAC" have developed a MOODLE (Modular Object-Oriented Dynamic Learning Environment) and ERP online platform various academic and administrative activities since the academic year 2018-19. To propagate the paperless work it was decided to conduct the In-semester MCQ assessment on MOODLE initially with 2 to 3 subjects. The

institute have appointed a MOODLE coordinator who is responsible to provide login ID's to students and assist them for smooth operation. Each respective staff is responsible for uploading the questions and conducts the online assessment.

- 5. Academics: JSPM's organizations "Digital Content Development DCD-ARQAC" have developed a MOODLE (modular object-oriented dynamic learning environment) and ERP online platform for availability to students learning material like faculty notes, e-books, PPT, educational/informative videos, important web links for additional information etc. Each faculty members are provided with login IDs through which faculty can upload the relevant content on MOODLE and student can access the same through their respective student login ID's. The respective subject teachers are responsible for uploading the econtent on MOODLE.
- 6. Accounts: For maintaining of ease and transparency in accounts institute have Tally, ERP 9 Gold software since from 2013. The institute accountant maintains the students fees accounts, cheque, invoice, online transductions in the tally software. The JSPMs organization have its own Jaywant Multistate Credit Cooperative Society Ltd in the campus only and have facility for payment of students fees through online as well as online.
- 7. **Library:** Institute have "Autolib Library Management software" since from 2011 for proper handling of books, their issuance and return installed in library. The book accession numbers are used against the student name and student number for issuance of book. The librarian is responsible to implement and e-governance policy in the library. The library also have e- journal subscription for students and faculty members and can access the journal through institute login ID's and password.
- 8. **Administration:** The institutional Email ID's are provided to all the faculty members for exchange of information/Notices/Circular etc. All communications from/to JSPM corporate office are made through institutional email ID's. The regulatory authorities' approvals are uploaded on website. The faculty recruitment is done as per the guidelines of SPPU where recruitment notifications are uploaded on institute website, online applications are invited from the eligible candidates and after selection the teacher

approval forms are filled online on SPPU web portal. The academic calendar, Class Time tables, In-semester and sessional examination time tables, Calendar for Co-curricular and Extra-curricular activities are prepared at the beginning of the academic year and displayed on institute website. Different committees are constituted formed for effective academic and administrative functioning and committee details are uploaded on the website. As a part of administration student verification can be done using institute website with inputs like Student name, PNR number, registered email ID, etc. Upcoming campus drives, News, Events organized and conducted by institute are displayed regularly.

College has started using **vmedulife** platform wherein the information of the institute is stored and accessed through the structured ERP. OBE (Outcome Based Education), Teaching & Learning and ERP (Enterprise Resource Planning) are the modules offered by vmedulife.
